### 4. First-Aid Measures

**First Aid - Eye Contact:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

**First Aid - Skin Contact:** Wash skin with soap and water. Remove contaminated clothing. Get medical attention if irritation develops or persists. Wash contaminated clothing and decontaminate footwear before reuse.

**First Aid - Inhalation:** Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention. ## 5. Fire-Fighting Measures

**EXTINGUISHING MEDIA:** Aqueous Film Forming Foam, Carbon Dioxide, Dry Chemical, Water Fog

**Unusual Fire and Explosion Hazards:** FLASH POINT IS LESS THAN -7°C (20°F). EXTREMELY FLAMMABLE LIQUID AND VAPOR! Water spray may be ineffective. Closed containers may explode when exposed to extreme heat. Vapors may form explosive mixtures with air. Vapors can travel to a source of ignition and flash back. ## 6. Accidental Release Measures

**Steps to Be Taken If Material Is Released or Spilled:** If spilled, contain spilled material and remove with inert absorbent. Contain spilled liquid with sand or earth. DO NOT use combustible materials such as sawdust. Remove all sources of ignition, ventilate area and remove with inert absorbent and non-sparking tools. ## 7. Handling and Storage

**Handling:** Wash thoroughly after handling. Wash hands before eating. Remove contaminated clothing and launder before reuse. Use only with adequate ventilation. Follow all SDS and label precautions even after container is emptied because it may retain product residues. Avoid breathing fumes, vapors, or mist. Avoid prolonged or repeated contact with skin. Do not get in eyes, on skin or clothing. Do not puncture or incinerate (burn) container, even after use.

**Storage:** Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Contents under pressure. Do not store above 120°F (49°C). ## 10. Stability and Reactivity

**Conditions to Avoid:** Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition. Avoid excess heat.

**Incompatibility:** Incompatible with strong oxidizing agents, strong acids and strong alkalis.

## 11. Toxicological Information
